

Win Every Day Contest on Recharge & Usage

TERMS & CONDITIONS – for Gujarat telecom circle

Please read these terms and conditions carefully before participating in the following Contest. By proceeding with participating in the said contest, you agree to be legally bound by these terms and conditions:

1. **Win Every Day** ('Contest') has been organized by Uninor for the telecom circle of Gujarat and is open from 14/02/2012 to 31/03/2012 ('Contest Period') for valid Uninor customers only.
